





### 3. Appointment of Alumni Mentors

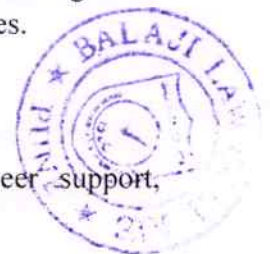
- a. Criteria for selecting alumni mentors were discussed.
