## Policy on Green Campus

### Introduction:

The "Green Campus Initiative" of Balaji Law College aims to create an environmentally conscious and sustainable campus environment that fosters a sense of responsibility towards nature and promotes eco-friendly practices among students, staff, and visitors. 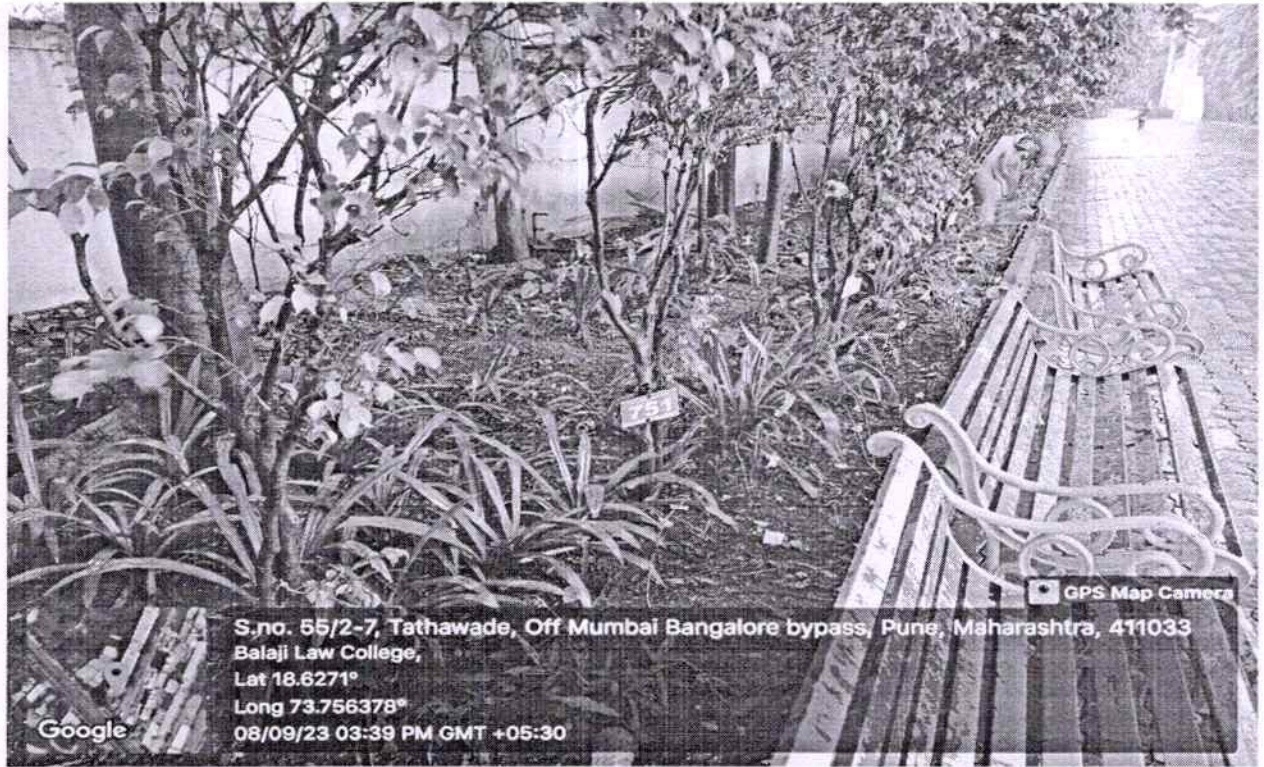
